We may collect the following data about you.

Information you provide to us by filling the registration form on our website www.redhillandreigateoseopathy.co.uk. This includes information collected at the time of registration or when making telephone bookings, subscribing to our service and/or requesting further correspondence from us.

We also use Google Analytics who collect traffic data on visits to our site. This is solely for the use of monitoring our online marketing efforts.

Where we store your personal data.
